

THIS AGREEMENT (hereinafter referred to as "Agreement") is entered into effective as of the 15th day of February, 2005, by and between SELLERS NAME (hereinafter "Customer") and Mail N Parcel (hereinafter "Mail N Parcel").

1. INTRODUCTION. Mail N Parcel is in the trade or business of assisting others in the sale of their property on eBay; and Customer desires to retain Mail N Parcel to assist in the sale of its property on eBay pursuant to the terms and conditions of this Agreement.

Accordingly, for good and valuable consideration, the parties hereto agree as follows:

2. PROPERTY. Customer agrees to deliver and pursuant to the terms of this Agreement, Mail N Parcel agrees to accept the bailment of the Customer's property listed and described on the Information Sheet attached as Annex 1 hereto (hereinafter referred to as "Property").

3. PURPOSE. Mail N Parcel shall hold the Property and list it for sale on eBay for a 7 or 10 day listing. When the auction is complete, Mail N Parcel will collect the money from the buyer. Mail N Parcel will then ship the Property to the buyer upon receipt of the shipping fees from the buyer. Once the return period is over, Mail N Parcel will mail Customer a check for the gross selling amount, less the Service Fee and eBay's listing and final value fees.

5. SELLING AGREEMENT. Mail N Parcel reserves the right to change descriptions to describe in more detail the item being sold. Mail N Parcel reserves the right to list items on eBay at their chosen time listing if said customer does not choose a time for the said item to be listed at the customers cost. This would be considered a scheduled listing.

5. PAYMENT AND SERVICE FEE. Customer agrees to pay Mail N Parcel a service fee based on the final eBay value (hereinafter "Final Value") of the Property as compensation for the services performed by Mail N Parcel (hereinafter the "Service Fee"). The Service Fee shall be determined according to the following scale:

- 28% of the sold price between \$0.01 and \$499.99
- 25% of the sold price between \$500.00 and \$999.99
- 20% of any amount over \$1000.00

Mail N Parcel advances all fees for Customer, including eBay, PayPal and any other fees. Buyers pay all shipping, packaging and insurance costs. Payment will be made to Customer by check via US Mail only after the auction transaction is completed. Auctions are based on the agreed amount of days. Payment, shipping and approval could take as many as 25 days. Once the approval period is over, Mail N Parcel will promptly send you a check for sale price minus the above commission and fees.

The terms of the online auction will be governed by eBay's applicable terms and conditions. The actual sales price will be the highest qualified bid received, subject to receipt of actual payment from the buyer. Mail N Parcel does not control the sales price, which may be less than what could be obtained through alternative means. The buyer has ten days to return the Property and receive a refund, if the item does not match the description. However, Customer must wait for the return period to end before Mail N Parcel settles with Customer. The entire process from listing your item until you receive your settlement could be 30 days. If the Property does not receive any bids, it has a Final Value of \$ 0.00. Customer is responsible for the eBay fees and service fees whether or not the Property sells on eBay. Mail N Parcel may deduct the eBay and PayPal fees and Service Fee from the sales proceeds of the Property. All eBay and PayPal fees incurred through the listing of the item are separate fees which Customer agrees to pay Mail N Parcel. If the Property does not sell through the efforts of Mail N Parcel, and Customer does not pick up the Property at Mail N Parcel's offices within thirty (30) days to a request by Mail N Parcel to pick up the Property, Mail N Parcel shall be free to dispose of the Property as it deems appropriate and Customer shall reimburse Mail N Parcel upon demand for all costs incurred by Mail N Parcel. If the Customer decides to relist the item, a fee of \$5.99 can be assessed.

PayPal fees are based upon how the buyer pays for the Customers item. PayPal is an internet bank that money is transferred from one user to another that is and in commonly used by internet users. As a PayPal user (As Mail N Parcel is), this will allow the customers item to be able to be sold at a higher price. PayPal will be allowed on all items sold through Mail N Parcel.

6. LIABILITY FOR LOSS OF PROPERTY. Customer assumes the risk of, and shall be responsible for, any loss or damage to the Property while the Property is in Mail N Parcel's possession or control. Customer shall insure the Property for its full replacement value and shall release Mail N Parcel from all liability with respect to the Property. In no event shall Mail N Parcel be liable to Customer for damages of any kind, including but not limited to special, incidental, or consequential damages, arising out of or in connection with the bailment, including but not limited to the use, testing, handling of any kind, operation or any other action reasonably connected to the services outlined in this contract. Mail N Parcel's liability to Customer shall not exceed the lesser of: (i) the estimated eBay value of Property at the time of listing; or (ii) \$100.

7. CUSTOMER REPRESENTATIONS. Customer hereby certifies that Customer is the lawful owner of the Property, has good and marketable title to the Property, and has the authority to enter into this Agreement and sell the Property free and clear of any claim or liability as provided for herein.

8. MAIL N PARCEL REPRESENTATIONS. Mail N Parcel is acting only as consignor of the Property. Mail N Parcel makes no representations or warranties in connection with this Agreement or the services performed and products provided in connection with this Agreement. The services performed and products provided under this Agreement are provided "AS IS" and without warranty, express, implied or statutory. Mail N Parcel specifically disclaims all implied warranties, including, but not limited to, the implied warranties of title, merchantability and fitness for a particular purpose. Mail N Parcel is not liable for any special, indirect, incidental, consequential or punitive damages that may arise from or in connection with this Agreement, their performance of this Agreement, or the sale of your item. In no case will Mail N Parcel be liable for actual damages in excess of the selling price of the Property, less our commission and fees.

9. APPLICABLE LAW. This Agreement shall be construed and interpreted in accordance with the laws of the State of Minnesota, without resort to said state's conflicts of laws rules. If any provision is found to be illegal or otherwise unenforceable by any court of competent jurisdiction or other judicial or administrative body, the other provisions shall not be affected thereby and shall remain in full force and effect. This Agreement is not intended by the parties to constitute or create a joint venture, pooling arrangement, partnership, or formal business organization of any kind, and the rights and obligations of the parties shall be only those expressly set forth herein. Neither party shall have the authority to bind the other except to the extent authorized herein.

10. COMPLETE AGREEMENT. This Agreement constitutes the complete and final Agreement between the parties and supersedes all prior representations and agreements of the parties both oral and written with respect to the subject matter hereof and may only be modified by a writing signed by both parties.
